# **SB 1383 Mandatory Requirements**

Starting January 1, 2022 SB 1383 requires all Multi-family properties in California with 5 or more units to subscribe to recycling, compost, and garbage service. AVI offers 50% discounts on compost service and a 25% discount on recycling service to help get your property in compliance.

#### What's Required from Property Owners Under SB 1383?

- Subscribe to compost, recycling and garbage service.
- Provide compost containers for employees and tenants at the same or at an equally convenient location as garbage.
- Provide information at least annually to employees, tenants, and contractors describing how to properly use the recycling, garbage, and food compost containers.
- Provide information to new tenants within 14 days of move-in and no less than 14 days prior to move-out.

# **Free Indoor Recycling Bins**

Free indoor bins are available to qualifying Alameda County multi-family residential properties (5+ units) for the collection of food scraps/organics. A variety of containers and lids are available—up to a value of \$500 per approved site including tax and delivery.

AVI offers a variety of collection services designed to meet your community's specific needs. We offer free resources to help make recycling and organics collection as convenient as possible for your tenants, employees, and contractors. ### **Mixed Recycling**

Acceptable materials include: clean, dry paper, empty glass and plastic containers, empty metal containers, and clean aluminum foil.

#### **Orgaincs Recycling**

Acceptable materials include: food scraps, food soiled paper, green waste/landscape debris, and untreated /unpainted wood.



## **Importance of Proper Sorting**



Film Plastic, Plastic Bags and Polystyrene are frequent contamination items. These items are NOT allowed in the recycling or compost containers.

In order to keep costs down and avoid future fines, residents of multi-family complexes must properly sort their food scraps/organics and recyclables into the correct bins.

**No plastic bags of any kind** are allowed in either the recycling or compost containers.

Do your part to keep the recycling stream clean, please keep all garbage bags, and other flimsy plastics, out of the recycling bin.
