### **Proper Sorting Makes a Difference Business Assistance**

Remember that business owners are required under SB 1383 and the Alameda County Organics Reduction and Recycling Ordinance to annually train all employees, tenants, and contractors on how to properly sort all materials into the 3-cart program. In order to avoid contamination fees, please make sure you and your employees know what is and isn't recyclable or compostable. Downloadable posters and guides are available at Amadorvallevindustries.com. Follow these tips to avoid contamination and service delays.



#### Keep it tidy

Collect food scraps in a bucket, kitchen pail, or paper bag for easy transport to the green compost bin.



#### Keep it clean

Remove stickers from produce. Do not put compostable plastic, plastic bags, glass or metal in the green compost bin.



#### **Do Not Bag Recyclables or Compost**

Make sure all recyclables are clean, dry, and loose in your recycling cart/bin. Unlined paper bags/ soiled paper are allowed in the green compost bin.



#### Set Up Disposal Areas

All disposal areas, both for staff and customers must be set up with the 3-cart system with proper labels and signage.

## What to Put in Your Compost Bin



All food scraps including vegetable scraps, cooked food, meat and bones, dairy products, tea bags and coffee grounds.





Food soiled paper products including pizza boxes, paper towels, napkins and paper plates. Do not add plastic-coated paper.

Landscaping and plant trimmings including leaves, grass clippings, branches and weeds.

## **Reusable Shipping Containers**

Reusable transport packaging prevents waste by replacing limited-life packaging used in manufacturing, transportation and/or distribution with durable alternatives, designed for many years of use; saving your business money and resources. Typical examples include the replacement of cardboard boxes with hand held containers, and switching to reusable pallets, pallet wraps and bands.



## **Reusable Transport Packaging Grants**

StopWaste offers up an annual funding opportunity of up to \$10,000 for reusable transport packaging projects in Alameda County or to reduce packaging used to transport materials/products originating outside of Alameda County that are shipped with an end destination in Alameda County.

This grant is available to nonprofits, for-profit organizations, institutions, and school districts. The next round of funding is scheduled to open in January 2024. Applications are usually due in March an awarded in May.
